About our Program and Speaker

Wade Burleson, Senior Pastor of Enid's Emmanuel Baptist Church since 1992, will present "*The Connection Between Abraham Lincoln and Enid.*" Wade has received the Outstanding Achievement Award by the Oklahoma Association of Broadcasters, was honored by the U. S. Department of Justice in 1996 for his work with victim's families at ground zero of the Alfred P. Murrah Federal Building, and received the Distinguished Silver Star from the Tulsa Police Department in the 1980's. A student of history and theology, Wade has authored seven books including *Happiness Doesn't Just Happen: Learning to Be Content Regardless of Your Circumstances*; *Red Earth Courage: The Amazing Story of the First Secret Mission of the Civil War*; and *A Transient Abode*, about John Wilkes Booth, Boston Cornet, and their bizarre connection to Enid, OK. He is a member of the Surratt Society in Washington, D.C., a group of experts on the assassination of Abraham Lincoln, and is part of a private team working with the Smithsonian Institution to conduct DNA tests on the remains John Wilkes Booth to confirm his death at Garrett's Barn. We look forward to this presentation.

The 400th Anniversary of the Landing of the Pilgrims Celebration Committee

October 10, 2013

[All] State Societies and members are invited to join a competition organized by the GSMD 2020 Committee to create a national logo for the GSMD celebration of the 400th Anniversary of the sailing of the Mayflower, the landing in Plymouth and the establishment of the Pilgrim colony.

Incorporate your ideas for both the celebration of this event and perhaps the future marketing image of GSMD into a design that you believe would be an appropriate symbol. You may organize your effort in any manner you see fit.

In order to insure that good ideas are not excluded, there will be no limit to the number of entries a state or its members may submit. All entries for the contest should be received by the Chair of the 2020 Committee Logo Contest before April 15, 2014. An independent jury of marketing professionals will review each entry and recommend a base group to the committee. Five of those entries will be published in the June Issue of the Mayflower Quarterly and those who wish to vote may do so. The winner will be announced at the triennial meeting of the General Congress in September 2014.

All entries will become the property of the GSMD unless the applicant is notified otherwise. More than one logo may be chosen for use by GSMD for special marketing applications for the 2020 celebration. If chosen as the winner, your submittal will be trademarked as a national GSMD logo. Prizes will be awarded to the top three logos selected. You will not be entitled to any other compensation.

The winning logo will serve as the identification and basis for all GSMD marketing for this event. You will receive recognition in both the Mayflower Quarterly and at certain select GSMD events. More information will be in the December Mayflower Quarterly.
